NICODEMUS F. AWASOM is presently a Senior Lecturer in History at the Faculty of Humanities and Social Sciences of the University of The Gambia/West Africa. His current research interests include constitutional political economy, African traditional rulers and governance in perspective, intergroup relations, the Anglophone problem in Cameroon and the Hausa-Fulani Muslim minorities in Cameroon's Western Grassfields, and globalisation and fundamentalist movements in Africa. His recent publications include articles in *Paideuma*, *Journal of Third World Studies* (in which connection he won the Lawrence Dunbar Reddick Memorial Scholarship Award 1998), *Africa Today*, *Epasa Moto*, *UNIBUEA* and *The Canadian Journal of African Studies*.

LEO DE HAAN is Director of the Centre for International Development Issues Nijmegen (CIDIN) and Professor in development studies at the University of Nijmegen. His main research interest consists of livelihood strategies of the rural and urban poor. He has conducted and co-ordinated research throughout West Africa, as well as Morocco and Tunisia, on agricultural commercialisation, labour migration, environmental management and conflicts between peasants and pastoralists. At the latter institution he founded the Department of Political and Historical Studies in 1980, to direct it in the subsequent decade. This book was initiated towards the end of his term of office as Head of the Theme Group on Globalisation (1996-2002) at the African Studies Centre. His research interests are African religion including Islam and Christianity; intercultural philosophy especially the epistemology of African Studies; African and Ancient history; Afrocentricity and the *Black Athena* debate; ethnicity and globalisation. He has pursued these interests in the course of extensive fieldwork in Tunisia, Zambia, Guinea Bissau, and Botswana. His recent publications include: *Black Athena Ten Years After*, 1997; *Virtuality as a key concept in the study of globalisation*, 1997; *Modernity on a shoestring* (with R. Fardon and R. van Dijk, 1999); *Culturen bestaan niet*, 1999; *Trajectoires de libération en Afrique contemporaine* (with Piet Konings and Gerti Hesseling, 2000); and *Intercultural encounters*, 2003.

FRANZ VON BENDA-BECKMANN is joint Head of the Project Group on Legal Pluralism at the Max Planck Institute for Social Anthropology in Halle, Germany. His research interests include legal anthropology, pluralism, decentralisation, village politics, and rights to natural resources. He conducted extensive fieldwork in Malawi and Indonesia (West Sumatra and Ambon). He has co-edited several books, and published numerous articles and book chapters on issues of property rights, social (in)security and legal pluralism in developing countries and on legal anthropological theory.

KEEBET VON BENDA-BECKMANN née DROOGLEEVER FORTUIJN is joint Head of the Project Group on Legal Pluralism at the Max Planck Institute for Social Anthropology in Halle, Germany, and professor in legal anthropology at the

Erasmus University Rotterdam. Her research has focused on dispute management and decentralisation in West Sumatra, on local forms of social security in the Moluccas and the Netherlands, on water rights in Nepal, and on theoretical problems related to legal pluralism.
